Buffalo United Charter School has not made any significant changes to its educational program.

Tammy Messmer continues to serve as school principal. Buffalo United is adopting a distributed leadership model. Under this model, the principal is supported in the leadership of the school by a team of deans. Each dean supervises the teachers in their grade groupings as well as additional support teams like special education, paraprofessionals and specials. These deans meet regularly with teachers and, through meetings and frequent classroom observations, help teachers establish instructional priorities for their classrooms and to use data to diagnose areas of weakness in student learning.
