**SUBJECT: Final Notice of Charter Renewals and Revisions – Operation of Law**

**DATE: July 12, 2021**

This final Notice, pursuant to New York Education Law §2857(1), is to inform you that the State University of New York Board of Trustees (the “SUNY Trustees”), in its capacity as a charter authorizer, approved the renewal and revision applications for the charter schools listed below, sent the paperwork to the New York State Board of Regents (“Board of Regents”), and the renewals and revisions have been approved by operation of law in accordance with the New York Charter Schools Act of 1998 (the “Act”). As the Act requires no further action, this will be the last notice on these items. A description of the actions are as follows:

**Renewals**

- **Achievement First Brooklyn Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
  - **Achievement First Voyager Charter School**, located at 601 Parkside Avenue, Brooklyn, NY 11226 in CSD 17, chartered to serve 240 students in grades 5-8, seeks a five year renewal of its charter commencing August 1, 2021. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 8, 2021.
  
- **Amber Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
  - **Amber Charter School Kingsbridge**, located at 3120 Corlear Avenue, Bronx, NY 10463 in CSD 10, chartered to serve 475 students in grades K-5, seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application, the school will grow to serve 875 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 8, 2021.

- **Brooklyn Prospect Charter School**, an education corporation operating more than one school, sought to renew its authority to operate the following charter school:
  - **Brooklyn Prospect Charter School – CSD 13**, located at 80 Willoughby Street, Brooklyn, NY 11201 and 1100 Fulton Street, Brooklyn, NY 11238 in CSD 13, chartered to serve 600 students in grades K-8 sought a five year renewal of its charter commencing August 1, 2021. According to the renewal application, the school will grow to serve 990 students in grades K-8.

The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about February 24, 2021; and, 3) the renewal was approved by operation of law on or about June 29, 2021.

- **Broome Street Academy Charter High School**, located at 121 Avenue of the Americas, New York, NY 10013 in CSD 2, chartered to serve 360 students in grades 9-12 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will serve 328 students in grades 9-12. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about March 17, 2021; and, 3) the renewal was approved by operation of law on or about June 29, 2021.
- **Capital Prep Charter Schools NY**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
  - **Capital Preparatory Harlem Charter School**, located at 1 East 104<sup>th</sup> Street, New York, NY 10029 in CSD 4, chartered to serve 400 students in grades 6-11 seeks a five year renewal of its charter commencing July 1, 2021. According to the renewal application, the school will grow to serve 700 students in grades 6-12.

The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal with conditions on or about February 24, 2021; and, 3) the renewal was approved by operation of law on or about June 30, 2021.

- **Icahn Charter School 2**, located at 1640 Bronxdale Avenue, Bronx, New York 10462 in CSD 11, chartered to serve 324 students in grades K – 8th grades seeks a five year renewal of its charter commencing August 1, 2022. According to the renewal application, the school will continue to serve 324 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about February 14, 2020; 2) approved a renewal through July 31, 2026 on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.
- **Icahn Charter School 3**, located at 1500 Pelham Parkway South, Bronx, New York 10461 in CSD 11, chartered to serve 324 students in grades K – 8th grades seeks a five year renewal of its charter commencing August 1, 2023. According to the renewal application, the school will continue to serve 324 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about February 14, 2020; 2) approved a renewal through July 31, 2026 on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.

- **Icahn Charter School 4**, located at 1500 Pelham Parkway South, Bronx, New York 10461 in CSD 11, chartered to serve 324 students in grades K – 8th grades seeks a five year renewal of its charter commencing August 1, 2024. According to the renewal application, the school will continue to serve 324 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about February 14, 2020; 2) approved a renewal through July 31, 2026 on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.
- **Icahn Charter School 6**, located at 1701 Fulton Avenue, Bronx, New York 10457 and 1776 Mansion Street, Bronx, New York 10460 in CSD 9 and 12, respectively, chartered to serve 378 students in grades K – 8th grades seeks a five year renewal of its charter commencing August 1, 2022. According to the renewal application, the school will continue to serve 324 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about February 14, 2020; 2) approved a renewal through July 31, 2026 on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.
- **Icahn Charter School 7**, located at 1535 Story Avenue, Bronx, New York 10473 and 1695 Seward Avenue, Bronx, New York 10473 in CSD 8, chartered to serve 324 students in grades K – 8th grades seeks a five year renewal of its charter commencing August 1, 2023. According to the renewal application, the school will continue to serve 324 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about February 14, 2020; 2) approved a renewal through July 31, 2026 on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.
- **New Visions Charter High School for Advanced Math and Science**, located at 99 Terrace View Avenue, Bronx, NY 10463 in CSD 10, chartered to serve 566 students in grades 9-12 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will continue to serve 566 students in grades 9-12. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about March 17, 2021; and, 3) the renewal was approved by operation of law on or about June 29, 2021.
- **New Visions Charter High School for the Humanities**, located at 99 Terrace View Avenue, Bronx, NY 10463 in CSD 10, chartered to serve 566 students in grades 9-12 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will continue to serve 566 students in grades 9-12. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about March 17, 2021; and, 3) the renewal was approved by operation of law on or about June 29, 2021.
- **Sisulu-Walker Charter School of Harlem**, located at 125 West 115<sup>th</sup> Street, New York, NY 10026 in CSD 3, chartered to serve 270 students in grades K-5 seeks a five year renewal of its charter commencing August 10, 2021. According to the renewal application the school will serve 240 students in grades K-5. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about February 24, 2021; and, 3) the renewal was approved by operation of law on or about June 8, 2021.

- **Success Academy Charter Schools – NYC**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter schools:
  - **Success Academy Charter School – Bed Stuy 3**, located at 787 Lafayette Avenue, Brooklyn, NY 11221 in CSD 16, chartered to serve 295 students in grades 5-7, seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will grow to serve 444 students in grades 5-8. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 8, 2021.
  - **Success Academy Charter School – Bronx 3**, located at 1000 Teller Avenue, Bronx, NY 10456 in Community School District 9 and 965 Longwood Avenue, Bronx, NY 10459 in CSD 8, chartered to serve 840 students in grades K-10 in the 2022-23 school year, the last year of the current charter term, seeks a five year renewal of its charter commencing August 1, 2023. According to the renewal application the school will grow to serve 2,148 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.
  - **Success Academy Charter School – Harlem 1**, located at 34 West 118<sup>th</sup> Street, New York, NY 10026, and 215 West 114<sup>th</sup> Street, New York, NY 11026 in CSD 3 and 111 East 33<sup>rd</sup> Street, New York, NY 10016 in CSD 2, chartered to serve 1,751 students in grades K-12, seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will grow to serve 1,938 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 8, 2021.
  - **Success Academy Charter School – Harlem 6**, located at 461 West 131<sup>st</sup> Street, New York, NY 10027 in CSD 5, chartered to serve 1,917 students in grades K-8 in the 2021-22 school year, the final year of the current charter term, seeks a five year renewal of its charter commencing August 1, 2022. According to the renewal application the school will serve 727 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about December 23, 2020; and, 3) the renewal was approved by operation of law on or about June 4, 2021.

### Revisions

- **Ascend Charter Schools**, an education corporation with the authority to operate more than one school has requested the following:
  - **East Brooklyn Ascend Charter School**, located at 260 Shepherd Avenue, Brooklyn, New York 11208 in New York City Community School District (“CSD”) 19, authorized to serve 135 students in grades K-1 for the 2020-21 school year, and growing to 378 students in grades K-4 for the 2023-24 school year, the final year of the current charter term, has requested an enrollment decrease to serve 54 students in grades K-1 for the 2020-21 school year, to grow to 243 students in grades K-4 for the 2023-24 school year. The education corporation opened three elementary schools in the

same school year some of which were located within existing schools, and has had lower enrollment than expected.

The SUNY Trustees: 1) received the revision application on or about July 27, 2020; and, 2) approved the revision on or about October 6, 2020; and, 3) the revision was approved by operation of law on February 19, 2021.

- **Capital Prep Charter Schools NY**, an education corporation with the authority to operate more than one school, has requested the following revision:
  - **Capital Preparatory Harlem Charter School**, located at 1 East 104th Street, New York, NY 10029 in CSD 4, and chartered to serve 400 students in grades 6-11 for the 2020-21 school year, the last year of the current charter term, seeks an enrollment revision to serve the same number of students but in grades 6-12. A cohort of current students have met the requirements to advance to grade 12, and the school will admit a small number of 12th grade students from other high schools.

The SUNY Trustees: 1) received the revision application on or about August 25, 2020; and, 2) approved the revision on or about October 6, 2020; and, 3) the revision was approved by operation of law on February 12, 2021.

- **Community Partnership Charter School Education Corporation**, a charter school education corporation with the authority to operate more than one school requested the following revision:
  - **Beginning with Children Charter School II**, located at 215 Heyward Street, Brooklyn, NY 11206 and 11 Bartlett Street, Brooklyn, NY 11206 in Community School District (“CSD”) 14, is authorized to serve 460 students in grades K-8 for the 2021-22 school year, the final year of the current charter term. The school sought to add a high school program beginning in the 2021-22 school year initially serving 90 students in grade 9. If renewed, the school would add a grade each year resulting in a high school enrollment of 342 students in grades 9-12.

The SUNY Trustees: 1) received the revision application on or about December 16, 2020; 2) approved the revision on or about March 17, 2021; and, 3) the revision was approved by operation of law on June 29, 2021.

- **Lewis Katz New Renaissance Basketball Academy Charter School**, to be located in Community School District (“CSD”) 7 and opening in the 2021-22 school year, has requested to change its name to the **Earl Monroe New Renaissance Basketball Charter School**. The SUNY Trustees: 1) received the revision application on or about October 19, 2020; 2) approved the revision on or about December 23, 2020; and, 3) the revision was approved by operation of law on April 22, 2021.
- **Manhattan Charter Schools**, a charter school education corporation with the authority to operate more than one school requested the following revision:
  - **Manhattan Charter School**, located 100 Attorney Street, Manhattan, NY 10002 in CSD 1, is authorized to serve 290 students in grades K-5 for the 2021-22 school year

through 2023-24 school year, the final year of the current charter term. The school requested an enrollment decrease to serve 240 students in grades K-5 for the 2021-22 school year through 2023-24 school year.

The SUNY Trustees: 1) received the revision application on or about January 12, 2021; and, 2) approved the revision on or about March 17, 2021; and, 3) the revision was approved by operation of law on June 29, 2021.

- **Success Academy Charter Schools – NYC**, an education corporation with the authority to operate more than one school, has requested the following revisions to align school enrollments with previously secured facilities and approved grade progressions. The revisions do not represent an overall increase in approved education corporation enrollment.
  - **Success Academy Charter School – Harlem 1**, located at 34 West 118th Street, New York, NY, 10026, 215 West 114th Street, New York, NY 10026, both in CSD 3; and 111 East 33rd Street, New York, NY 10016 in CSD 2.
  - **Success Academy Charter School – Bed Stuy 2**, located at 211 Throop Avenue, Brooklyn, NY 11206 in CSD 14.
  - **Success Academy Charter School – Cobble Hill**, located at 284 Baltic Street, Brooklyn, New York 11201 in CSD 15.
  - **Success Academy Charter School – Williamsburg**, located at 183 South 3rd Street, Brooklyn, NY 11211 in CSD 14.

Success Academy Charter School – Bed Stuy 2, currently authorized to serve 453 students in grades K-4 and 9 for the 2020-21 school year, Success Academy Charter School – Cobble Hill, currently authorized to serve 460 students in grades K-4 and 9 for the 2020-21 school year, and Success Academy Charter School – Williamsburg, currently authorized to serve 483 students in grades K-4 and 9 for the 2020-21 school year, all request an enrollment decrease due to facility constraints to serve only grades K-4 with enrollments of 416, 416, and 446, respectively. Success Academy Charter School – Harlem 1, currently authorized to serve 1,633 students in grades K-12 for the 2020-21 school year requests an enrollment increase to serve 1,751 students in grades K-12 for the 2020-21 school year, the final year of the current charter term, to accommodate the previously approved grade 9 students from the schools listed above.

- **Success Academy Charter School – Bergen Beach**, located at 1420 East 68th Street, Brooklyn, NY 11234 and 3109 Newkirk Avenue, Brooklyn, NY 11226, both in CSD 22.
- **Success Academy Charter School – Union Square**, located at 40 Irving Place, New York, NY 10003 and 500 West 41st Street, New York, NY 10018, both in CSD 2.

Success Academy Charter School – Union Square, currently authorized to serve 1,534 students in grades K-8 for the 2020-21 school year, requests an enrollment decrease due to facility constraints to serve 1,184 students in grades K-8 for the 2020-21 school year. Success Academy Charter School – Bergen Beach, currently authorized to serve 666 students in grades K-7 for the 2020-21 school year, requests an enrollment increase to serve 1,016 students in grades K-7 to accommodate the previously approved students from Success Academy Charter School – Union Square.

- **Success Academy Charter School – Bushwick**, located at 139 Menahan Street, Brooklyn, NY 11221 in CSD 32.
- **Success Academy Charter School – Flatbush**, located at 15 Snyder Avenue, Brooklyn, NY 11226 in CSD 17.
- **Success Academy Charter School – Rosedale**, located at 147-65 249th Street, Queens, NY 11422 and 88-15 182nd Street, Queens, NY 11423, both in CSD 29.

Success Academy Charter School – Bushwick, currently authorized to serve 675 students in grades K-5 for the 2020-21 school year, and Success Academy Charter School – Flatbush, currently authorized to serve 675 students in grades K-5 for the 2020-21 school year, both request enrollment decreases due to facility constraints to only serve 602 students in grades K-4. Success Academy Charter School – Rosedale, currently authorized to serve 445 students in grades K-4 for the 2020-21 school year, requests an enrollment increase to serve 664 students in grades K-5 for the 2020-21 school year to accommodate the previously approved students from the schools listed immediately above.

- **Success Academy Charter School – Bensonhurst**, located at 99 Avenue P, Brooklyn, NY 11204 in CSD 21.
- **Success Academy Charter School – South Jamaica**, located at 120-27 141st Street, Jamaica, New York 11436 in CSD 27.

Success Academy Charter School – South Jamaica, currently authorized to serve 675 students in grades K-5 for the 2020-21 school year, requests an enrollment decrease due to facility constraints to serve 452 students in grades K-4. Success Academy Charter School – Bensonhurst, currently authorized to serve 445 students in grades K-4 for the 2020-21 school year, requests an enrollment increase to serve 595 students in grades K-4 for the 2020-21 school year to accommodate certain students from Success Academy Charter School – South Jamaica. Previously approved grade 5 students from Success Academy Charter School – South Jamaica would be served at Success Academy Charter School – Rosedale (see above).

- **Success Academy Charter School – Bed Stuy 1**, located at 70 Tompkins Avenue, Brooklyn, NY 11206 in CSD 14.
- **Success Academy Charter School – Bronx 1**, located at 339 Morris Avenue, Bronx, NY 10451 in CSD 7.
- **Success Academy Charter School – Washington Heights**, located at 701 Fort Washington Avenue, New York, NY 10040 in CSD 6.

Success Academy Charter School – Bed Stuy 1, currently authorized to serve 1,631 students in grades K-8 for the 2020-21 school year, requests an enrollment decrease due to facility constraints to serve 1,131 students in grades K-8. Success Academy Charter School – Bronx 1, currently authorized to serve 446 students in grades K-4 for the 2020-21 school year, requests an enrollment increase to serve 596 students in grades K-4 to accommodate the previously approved students from Success Academy Charter School – Bed Stuy 1. Success Academy Charter School – Washington Heights, currently authorized to serve 445 students in grades K-4 for the 2020-21 school year, requests an enrollment increase to serve 645 students in grades K-4 accommodating previously approved students from Success Academy Charter School – Bed Stuy 1.

- **Success Academy Charter School – Bronx 4**, located at 885 Bolton Avenue, Bronx, NY 10473 in CSD 8.
- **Success Academy Charter School – Fort Greene**, located at 101 Park Avenue, Brooklyn, NY 11205 in CSD 13.

Success Academy Charter School – Fort Greene, currently authorized to serve 446 students in grades K-4 for the 2020-21 school year, requests an enrollment decrease due to facility constraints to serve 266 students in grades K-4. Success Academy Charter School – Bronx 4, currently authorized to serve 445 students in grades K-4 for the 2020-21 school year, requests an enrollment increase to serve 625 students in grades K-4 to accommodate the students from Success Academy Charter School – Fort Greene.

- **Success Academy Charter School – Harlem 3**, located at 410 East 100th Street, New York, NY 10029 in CSD 4; 141 East 111th Street, New York, NY 10029 in CSD 4; and high school grades temporarily located at 111 East 33rd Street, New York NY 10016 in CSD 2 until a high school facility at 878 Brook Avenue, Bronx, NY in CSD 7 is complete.
- **Success Academy Charter School – Harlem 5**, located at 301 West 140th Street, New York, NY 10030 and 175 West 134th Street, New York, NY 10030, both in CSD 5.
- **Success Academy Charter School – Upper West**, located at 145 West 84th Street, New York, NY 10024 in CSD 3 and 439 West 49th Street, New York, NY 10019 in CSD 2.

Success Academy Charter School – Harlem 3, currently authorized to serve 2,128 students in grades K-12 for the 2020-21 school year, requests an enrollment decrease due to facility constraints to serve 1,778 students in grades K-12. Success Academy Charter School – Harlem 5, currently authorized to serve 705 students in grades K-8 for the 2020-21 school year, requests an enrollment increase to serve 955 students in grades K-8, and Success Academy Charter School – Upper West, currently authorized to serve 753 students in grades K-8 for the 2020-21 school year, requests an enrollment increase to serve 853 students in grades K-8, both to accommodate previously approved students from Success Academy Charter School – Harlem 3.

The SUNY Trustees: 1) received the revision applications on or about May 15, 2020; and, 2) approved the revisions on or about October 6, 2020; and, 3) the revisions were approved by operation of law on October 16, 2020.

- **The International Charter School of New York**, a charter school education corporation with the authority to operate one school, located at 55 Willoughby Street, Brooklyn, NY 11201 in CSD 13 and 9 Hanover Place, Brooklyn, NY 11201 in CSD 15, sought to merge with **Brooklyn Prospect Charter School**, a charter school education corporation with the authority to operate:
  - **Brooklyn Prospect Charter School – CSD 13** located at 80 Willoughby Street, Brooklyn, NY 11201 and 1100 Fulton Street, Brooklyn, NY 11238 in CSD 13;
  - **Brooklyn Prospect Charter School – CSD 15** located at 3002 Fort Hamilton Parkway, Brooklyn NY 11218 in CSD 15 and 40 Flatbush Avenue, Brooklyn, NY 11201 in CSD 13; and,



- **Brooklyn Prospect Charter School – CSD 15.2** located at 3002 Fort Hamilton Parkway, Brooklyn NY 11218 in CSD 15 and 40 Flatbush Avenue, Brooklyn, NY 11201 in CSD 13,

such that when the merger was approved, **Brooklyn Prospect Charter School** would be the successor education corporation. The request also sought the following enrollment revisions:

- **The International Charter School of New York** is chartered to serve 510 students in grades K-5 for the 2021-22 school year and 525 students in grades K-5 for the 2022-23 school year, the final year of the current charter term. The merger requested the school serve 375 students in grades K-5 for the 2021-22 school year and 355 students in grades K-5 for the 2022-23 school year.
- **Brooklyn Prospect Charter School – CSD 15.2** is chartered to serve 1,035 students in grades K-1 and 6-12 in the 2021-22 school year and requested to serve 1,045 students in grades K-1 and 6-12 in the 2021-22 school year. The request does not request to revise enrollment in any additional year of the current charter term.
- **Brooklyn Prospect Charter School – CSD 15** is chartered to serve 55 students in grade K for the 2021-22 school year growing to serve 165 students in grades K-2 for the 2023-24 school year, the final year of the current charter term. The merger requested this elementary program commence in the 2022-23 school year with 55 students in grade K growing to 110 students grades K-1 for the 2023-24 school year.

The SUNY Trustees: 1) received the revision applications on or about November 4, 2020; and, 2) approved the revisions on or about February 24, 2021; and, 3) the revisions were approved by operation of law on June 29, 2021.
