**SUBJECT: Final Notice of Charter Applications, Renewals, and Revisions – Operation of Law**

**DATE: November 22, 2021**

This final Notice, pursuant to New York Education Law §2857(1), is to inform you that the State University of New York Board of Trustees (the “SUNY Trustees”), in its capacity as a charter authorizer, approved the new charter school, merger, renewal, and revision applications for the charter schools listed below, sent the materials the New York State Board of Regents (“Board of Regents”), and the items have been approved by operation of law in accordance with the New York Charter Schools Act of 1998 (the “Act”). As the Act requires no further action, this will be the last notice on these items. A description of the actions are as follows:

The SUNY Trustees: 1) received the new charter applications on or about February 16, 2021; 2) approved the applications on June 15, 2021; and 3) the applications were approved by operation of law on September 28, 2021.

## **Renewals**

- **Buffalo United Charter School**, located at 325 Manhattan Avenue, Buffalo, NY 14214 in the Buffalo City School District, chartered to serve 760 students in grades K-8 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will serve 681 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about September 17, 2020; 2) approved a five year renewal with conditions on or about March 17, 2021; and 3) the renewal was approved by operation of law on July 29, 2021.
- **Bronx Charter School for Excellence**, an education corporation operating more than one school, sought to renew its authority to operate the following charter school:
  - **Bronx Charter School for Excellence 2**, located at 1804 Holland Avenue, Bronx, NY 10462 in Community School District (“CSD”) 11 and 1946 Bathgate Avenue, Bronx NY 10457 in CSD 9, chartered to serve 360 students in grades K-5 sought a five year renewal of its charter commencing August 1, 2021. According to the renewal application, the school will grow to serve 540 students in grades K-8.

The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about March 17, 2021; and 3) the renewal was approved by operation of law on August 5, 2021.

- **Broome Street Academy Charter High School**, located at 121 Avenue of the Americas, New York, NY 10013 in CSD 2, chartered to serve 360 students in grades 9-12 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will serve 328 students in grades 9-12. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about March 17, 2021; and 3) the renewal was approved by operation of law on July 29, 2021.
- **Democracy Prep New York Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
  - **Harlem Prep Charter School**, located at 232 East 103<sup>rd</sup> Street, New York, NY 10029 and 240 East 123<sup>rd</sup> Street, New York, NY 10035 in CSD 4, chartered to serve 1,061 students in grades K-12 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application, the school will serve 1,020 students in grades K-12.

The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about February 24, 2021; and 3) the renewal was approved by operation of law on July 29, 2021.

- **KIPP: Albany Community Public Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
  - **Albany Community Charter School**, located at 65 Krank Street and 42 South Dove Street, Albany, NY 12202 in the Albany City School District, chartered to serve 675 students in grades K-8 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will grow to serve 743 students in grades K-8.

The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal on or about March 17, 2021; and 3) the renewal was approved by operation of law on July 29, 2021.

- **New York City Charter School of the Arts**, located at 26 Broadway, New York, NY, 10004 in CSD 2, chartered to serve 306 students in grades 6-8 seeks a five year renewal of its charter commencing August 1, 2021. According to the renewal application the school will grow to serve 270 students in grades 6-8. The SUNY Trustees: 1) received the renewal application on or about August 17, 2020; 2) approved a five year renewal with conditions on or about February 24, 2021; and 3) the renewal was approved by operation of law on July 29, 2021.

### Revisions

- **Albany Leadership Charter High School for Girls**, located at 19 Hackett Boulevard, Albany, New York 12208, in the Albany City School District requests to change its education corporation and school name to **Albany Leadership Charter School for Girls**. The SUNY Trustees: 1) received the revision application on or about May 12, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on October 19, 2021.
- **Amber Charter Schools**, an education corporation with the authority to operate more than one school, has requested the following revision:
  - **Amber Charter School Inwood**, to be located at 532 West 215<sup>th</sup> Street, New York, New York in CSD 6, is currently authorized to serve 400 students in grades K-1 and 5-6 for the 2021-22 school year growing to serve 923 students in grades K-8 by the 2025-26 school year, the final year of the current charter term, requests an enrollment decrease to serve 200 students in grades K-1 for the 2021-22 school year growing to serve 600 students in grades K-5 by the 2025-26 school year.

The SUNY Trustees: 1) received the revision application on or about March 3, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on August 12, 2021.

- **Atmosphere Academy Public Charter Schools**, located at 5959 Broadway, 22 Marble Hill Avenue, and 3700 Independence Avenue, Bronx, NY 10463 in CSD 10, is currently authorized to serve 600 students in grades 6-8 through the 2024-25 school year, the last year of the current charter term. The school requests to add a high school program starting in the 2022-23 school with 400 additional students in grades 9-10. The school proposes to add one grade each year for a total of 800 additional students in grades 9-12. The school's total chartered enrollment

would be 1,400 students by the 2024-25 school year. The SUNY Trustees: 1) received the revision application on or about February 14, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on August 10, 2021.

- **International Leadership Charter High School**, located at 3030 Riverdale Avenue, Bronx, NY 10463 in CSD 10, is currently authorized to serve 420 students in grades 9-12 for the 2022-23 school year through the 2024-25 school year, the last year of the current charter term. The school requests to add a middle school program starting in the 2022-23 school year with 100 additional students in the 6<sup>th</sup> grade and adding a grade each year for a total of 300 additional students in grades 6-8. The school's total chartered enrollment would be 720 students for the 2024-25 school year. The SUNY Trustees: 1) received the revision application on or about October 14, 2020; and, 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on September 30, 2021.
- **Merrick Academy – Queens Public Charter School**, located at 136-25 218<sup>th</sup> Street, Queens, NY 11413 in CSD 29, sought to add two at-risk preferences to its admissions policy for the 2021-22 school year and beyond providing a preference for students with disabilities and English Language Learners. The SUNY Trustees: 1) received the revision application on or about January 20, 2021; 2) approved the revision on or about March 17, 2021; and 3) the revision was approved by operation of law on August 9, 2021.
- **New World Preparatory Charter School**, located at 355 Morning Star Road, Staten Island, New York 10303, 285 Clove Road, Staten Island, New York 10310 and 130 Merrill Avenue, Staten Island, New York 10314 in CSD 31, is currently authorized to serve 609 students in grades K-3 and 5-8 for the 2021-22 school year growing to serve 685 students in grades K-8 for the 2022-23 school year, the final year of the current charter term, requests an enrollment increase to serve 720 students in grades K-3 and 5-8 for the 2021-22 school year growing to serve 794 students in grades K-8 for the 2022-23 school year. The SUNY Trustees: 1) received the revision application on or about April 6, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on September 30, 2021.
- **Success Academy Charter Schools – NYC**, an education corporation with the authority to operate more than one school, has requested the following revision to align school enrollments with secured facilities and approved grades progressions while limiting student disruption. The SUNY Trustees: 1) received the revision application on or about May 7, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on November 3, 2021.
  - **Success Academy Charter School – Bronx 3** (“Bronx 3”), located at 1000 Teller Ave., Bronx, NY 10456 in CSD 9 and 965 Longwood Ave., Bronx, NY 10459 in CSD 8, is currently authorized to serve 781 students in grades K-9 for the 2021-22 school year growing to 1,968 students in grades K-11 by the 2023-24 school year. The school requests an enrollment increase to 1,742 students in grades K-9 for the 2021-22 school year growing to 2,068 students in grades K-12 by the 2023-24 school year. This will align current chartered enrollment growth and accommodate students from the following schools:
    - **Success Academy Charter School – Bed Stuy 1** (“Bed Stuy 1”), located at 70 Tompkins Ave., Brooklyn, NY 11206 in CSD 14, is currently authorized to serve 1,079 students in grades K-11 for the 2021-22 school year. Bed Stuy 1 has requested a one year enrollment decrease to

- serve 929 students in grades K-8 for the 2021-22 school year. The 150 students to be served in grades 9-11 will be accommodated by Bronx 3.
- **Success Academy Charter School – Harlem 2** (“Harlem 2”), located at 144 East 128<sup>th</sup> St., New York, NY 10035 and 509 West 129<sup>th</sup> St., New York, NY 10027, both in CSD 5, is currently authorized to serve 895 students in grades K-8 for the 2021-22 school year and 869 students in grades K-8 for the 2022-23 school year. The school requests an enrollment reduction to serve 506 students in grades K-4 for the 2021-22 and 2022-23 school years. Approximately 376 students to be served in grades 5-8 will be accommodated by Bronx 3.
  - **Success Academy Charter School – Upper West** (“Upper West”), located at 145 West 84<sup>th</sup> St., New York, NY 10024 in CSD 3 and 439 West 49<sup>th</sup> St., New York, NY 10019 in CSD 2, is currently authorized to serve 1,114 students in grades K-11 for the 2021-22 school year. Upper West requests a one year enrollment decrease to serve 964 students in grades K-8 for the 2021-22 school year. The 150 students to be served in grades 9-11 will be accommodated by Bronx 3.
- **Success Academy Charter School – South Jamaica** (“South Jamaica”), located at 120-27 141<sup>st</sup> St., Jamaica, NY 11436 in CSD 27, is currently authorized to serve 369 students in grades K-4 for the 2021-22 school year. South Jamaica requests a one year enrollment increase to serve 504 students in grades K-4 for the 2021-22 school year to accommodate students from the following school:
    - **Success Academy Charter School – Bed Stuy 2** (“Bed Stuy 2”), located at 211 Throop Ave., Brooklyn, NY 11206 in CSD 14, is currently authorized to serve 418 students in grades K-4 for the 2021-22 school year. Bed Stuy 2 requests a one year enrollment decrease to serve 283 students in grades K-4. The 135 students to be served in grades 1-3 will be accommodated by South Jamaica.
  - **Success Academy Charter School – Bed Stuy 3** (“Bed Stuy 3”), located at 787 Lafayette Avenue, Brooklyn, NY 11221 in CSD 16, is currently authorized to serve 307 students in grades 5-8 for the 2021-22 school year growing to 444 students in grades 5-8 by the 2023-24 school year. Bed Stuy 3 requests an enrollment revision to serve 247 students in grades 5-8 for the 2021-22 school year growing to serve 734 students in grades 5-8 by the 2023-24 school year.
  - **Success Academy Charter School – Far Rockaway** (“Far Rockaway”), located at 10-45 Nameoke St., Queens, NY 11691 in CSD 27, is currently authorized to serve 522 students in grades K-4 for the 2021-22 school year. Far Rockaway requests a one year enrollment increase to serve 772 students in grades K-6 for the 2021-22 school year to accommodate students from Bed Stuy 3.
  - **Success Academy Charter School – Flatbush** (“Flatbush”), located at 15 Snyder Ave., Brooklyn, NY 11226 in CSD 17, is currently authorized to serve 454 students in grades K-4 for the 2021-22 school year. Flatbush requests a one year enrollment increase to serve 604 students in grades K-4 for the 2021-22 school year to accommodate students from the following school:
    - **Success Academy Charter School – Hudson Yards** (“Hudson Yards”), located at 500 West 41<sup>st</sup> St., New York, NY 10018 in CSD 2, is currently authorized to serve 675 students in grades K-5 for the 2021-22 school year. Hudson Yards requests a one year enrollment reduction to serve 452 students in grades K-4 for the 2021-22 school year.

One hundred fifty elementary students will be accommodated by Flatbush and the 73 students to be served in grade 5 will be accommodated by Bronx 3.

- **Success Academy Charter School – Harlem 1** (“Harlem 1”), located at 34 West 118<sup>th</sup> St., New York, NY 10026 and 215 West 114<sup>th</sup> St., New York, NY 10026, both in CSD 2, and 111 East 33<sup>rd</sup> St., New York 10016 in CSD 3, is currently authorized to serve 1,795 students in grades K-12 for the 2021-22 school year growing to 1,938 students in grades K-12 by the 2023-24 school year. Harlem 1 requests an enrollment revision to serve 1,820 students in grades K-12 for the 2021-22 school year growing to 1,838 students in grades K-12 for the 2023-24 school year to accommodate students from the following schools:
  - **Success Academy Charter School – Crown Heights** (“Crown Heights”), located at 330 Crown St., Brooklyn, NY 11225 and 72 Veronica Pl., Brooklyn, NY 11226, both in CSD 17, is currently authorized to serve 824 students in grades K-9 for the 2021-22 school year. Crown Heights requests a one year enrollment revision to serve 1,084 students in grades K-8 for the 2021-22 school year to accommodate middle school students from Bronx 3 due to facility constraints. The 40 students to be served in grade 9 will be accommodated by Harlem 1.
  - **Success Academy Charter School – Fort Greene** (“Fort Greene”), located at 101 Park Ave., Brooklyn, NY 11205 in CSD 13, is currently authorized to serve 301 students in grades K-4 and 9 for the 2021-22 school year. Fort Greene requests a one year enrollment revision to serve 266 students in grades K-4. The 35 students to be served in grade 9 will be accommodated by Harlem 1.
  - **Success Academy Charter School – Hell’s Kitchen** (“Hell’s Kitchen”), located at 439 West 49<sup>th</sup> St., New York, NY 10019 in CSD 2, is currently authorized to serve 456 students in grades K-4 and 9 for the 2021-22 school year. Hell’s Kitchen requests a one year enrollment revision to serve 415 students in grades K-4 for the 2021-22 school year. The 41 students to be served in grade 9 will be accommodated by Harlem 1.
  - **Success Academy Charter School – Prospect Heights** (“Prospect Heights”), located at 801 Park Pl., Brooklyn, NY 11216 in CSD 17 and 700 Park Ave., Brooklyn, NY 11206 in CSD 14, is currently authorized to serve 1,039 students in grades K-9 for the 2021-22 school year. Prospect Heights requests a one year enrollment revision to serve 899 students in grades K-8 for the 2021-22 school year. A portion of students in grade 6 will be accommodated by Bronx 2 and the 40 students to be served in grade 9 will be accommodated by Harlem 1.
  - **Success Academy Charter School – Union Square** (“Union Square”), located at 40 Irving Place, New York, NY 10003 and 500 West 41<sup>st</sup> St., New York, NY 10018, both in CSD 2, is currently authorized to serve 1,296 students in grades K-9 for the 2021-22 school year. Union Square requests a one year enrollment revision to serve 1,230 students in grades K-8 for the 2021-22 school year. The 66 students to be served in grade 9 will be accommodated by Harlem 1.
- **Success Academy Charter School – Harlem 6** (“Harlem 6”), located at 461 West 131<sup>st</sup> St., New York, NY 10027 in CSD 5, is currently authorized to serve 1,917 students in grades K-8 for the 2021-22 school year and 727 students in grades K-8 by the 2024-25 school year. Harlem 6 requests an enrollment revision to serve 402 student in grades K-4 for the 2021-22 school year growing to serve 1,307 students in grades K-8 by the 2024-25 school year.
  - **Success Academy Charter School – Bensonhurst** (“Bensonhurst”), located at 99 Avenue P, Brooklyn, NY 11204 in CSD 21, is currently authorized to serve 445 students in grades



- K-4 for the 2021-22 school year. Bensonhurst requests a one year enrollment revision to serve 645 students in grades K-4 to accommodate 200 students from Harlem 6.
- **Success Academy Charter School – Harlem 5** (“Harlem 5”), located at 301 West 140<sup>th</sup> St., New York, NY 10030 and 175 West 134<sup>th</sup> St. New York, NY 10030, both in CSD 5, is currently authorized to serve 956 students in grades K-8 for the 2021-22 school year. Harlem 5 requests a one year enrollment revision to serve 1,252 students in grades K-8 to accommodate 296 students from Harlem 6.
  - **Success Academy Charter School – Rosedale** (“Rosedale”), located at 147-65 249<sup>th</sup> St., Queens, NY 11422 and 88-15 182<sup>nd</sup> St., Queens, NY 11423, both in CSD 29, is currently authorized to serve 708 students in grades K-6 for the 2021-22 school year. Rosedale requests a one year enrollment revision to serve 1,089 students in grades K-6 to accommodate 381 students from Harlem 6.
- **Success Academy Charter School – Williamsburg** (“Williamsburg”), located at 183 South 3<sup>rd</sup> St., Brooklyn, NY 11211 in CSD 14, is currently authorized to serve 541 students in grades K-4 for the 2021-22 school year. Williamsburg requests a one year enrollment decrease to serve 446 students in grades K-4 for the 2021-22 school year aligning its chartered enrollment to its 2020-21 chartered enrollment level.
  - **Success Academy Charter School – Bronx 2** (“Bronx 2”), located at 450 St. Pauls Pl., Bronx, NY 10456 and 270 East 167 St., Bronx, NY 10456, both in CSD 9, is currently authorized to serve 999 students in grades K-8 for the 2020-21 school year and 446 students in grades K-4 for the 2021-22 school year. Bronx 2 requests a one year enrollment revision to serve 1,357 students in grades K-8 for the 2021-22 school year to align is current chartered enrollment pattern and to accommodate students from Bed Stuy 3, Harlem 6 and Hudson Yards.
- **The Academy Charter School**, an education corporation with the authority to operate more than one school, has requested the following revision:
    - **The Academy Charter School - Uniondale**, located at 100 Charles Lindbergh Blvd, Uniondale, New York 11553 in the Uniondale Union Free School District, is currently authorized to serve 650 students in grades K-5 and 9-10 for the 2021-22 school year growing to serve 850 students in grades K-6 and 9-11 for the 2022-23 school year, the final year of the current charter term, requests an enrollment increase to serve 950 students in grades K-6 and 9-10 for the 2021-22 school year growing to serve 1,225 students in grades K-7 and 9-11 by the 2022-23 school year. The SUNY Trustees: 1) received the revision application on or about March 31, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on September 30, 2021.
  - **Uncommon New York City Charter Schools**, an education corporation with the authority to operate more than one school, has requested the following revision:
    - **Brooklyn East Collegiate Charter School**, located at 832 Marcy Ave., Brooklyn, NY 11216 in CSD 13, is currently authorized to serve 277 students in grades 5-8 for the 2021-2022 school year with an enrollment of 264 students in grades 5-8 for the 2024-25 school year, the final year of the current charter term. The school requests an enrollment revision to serve 100 students in grades 7-8 for the 2021-22 school year, 132 students in grades K and 8 for the 2022-23 school year, 174 students in grades K-1 for the 2023-24 school year, and 261

students in grades K-2 for the 2024-25 school year. The SUNY Trustees: 1) received the revision application on or about May 3, 2021; 2) approved the revision on or about June 15, 2021; and 3) the revision was approved by operation of law on October 19, 2021.
