SUBJECT: Second Notice of Charter Extension(s) and Renewal(s) – SUNY Trustee Approval

This updated Notice is to inform you that the State University of New York Board of Trustees (the "SUNY Trustees"), in its capacity as a charter authorizer, approved the renewal(s) to the charter(s) of the charter school(s) listed below.

A description of the proposed action(s) follows:

- **Broome Street Academy Charter High School**, located at 121 Avenue of the Americas, New York, NY 10013, in Community School District ("CSD") 2, currently serving approximately 325 students in grades 9-12, seeks a five year renewal of its charter commencing August 1, 2016. According to the renewal application, the school would grow to serve approximately 360 students in grades 9-12. The SUNY Trustees: 1) received the renewal application on or about August 31, 2015; and, 2) approved it on February 25, 2016.
- **Harlem Prep Charter School**, located at 240 East 123rd Street, New York, NY 10035 and 410 East 100th Street, New York, NY 10029, in CSD 4, currently serving approximately 756 students in grades K-8, seeks a five year renewal of its charter commencing August 1, 2016. According to the renewal application, the school would grow to serve approximately 1061 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 31, 2015; and, 2) approved it on February 25, 2016.
- **Uncommon New York City Charter Schools**, an education corporation operating more than one school, seeks to renew its charter and authority to operate **Leadership Preparatory Bedford Stuyvesant Charter School**, located at 141 Macon Street,

Brooklyn, NY, in CSD 13, currently serving approximately 1011 students in grades K-12, booth for five years commencing August 1, 2016. According to the renewal application, the school would grow to serve approximately 1338 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 31, 2015; and, 2) approved it on February 25, 2016.

- **Sisulu-Walker Charter School of Harlem**, located at 125 West 115th Street, New York, NY 10026, in CSD 3, currently serving approximately 270 students in grades K-5, seeks a five year renewal of its charter commencing August 1, 2016. According to the renewal application, the school would continue to serve the same enrollment. The SUNY Trustees: 1) received the renewal application on or about August 31, 2015; and, 2) approved it on February 25, 2016.

Please take further Notice that the SUNY Trustees have sent or will send the proposed renewal(s) to the New York State Board of Regents for approval or action consistent with the New York Charter Schools Act of 1998.
