This updated Notice, pursuant to New York Education Law § 2857(1), is to inform you that the State University of New York Board of Trustees (the “SUNY Trustees”), in its capacity as a charter authorizer, approved renewal(s) of the charter(s) of the charter school(s) listed below.

Description(s) of the proposed action(s) are as follows:

- **Brilla College Preparatory Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
 - **Brilla College Preparatory Charter School**, located at 413 E. 144th Street, Bronx, NY 10454 in Community School District (“CSD”) 7, currently serving approximately 437 students in grades K-5, seeks a five year renewal of its authority to operate commencing July 1, 2018. According to the renewal application the school will grow to serve 727 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; and, 2) approved a five year renewal on December 11, 2017.
- **DREAM Charter School**, located at 1991 2nd Avenue, New York, NY 10029 in CSD 4, currently serving approximately 474 students in grades K-8, seeks a five year renewal of its charter commencing July 1, 2018. According to the renewal application the school will grow to serve 922 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; and, 2) approved a five year renewal on December 11, 2017.

- **Uncommon New York City Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter schools:
 - **Bedford Stuyvesant Collegiate Charter School**, located at 800 Gates Avenue, 4th Floor, Brooklyn, NY 11221 in CSD 16, currently serving approximately 312 students in grades 5-8, seeks a five year renewal of its authority to operate commencing August 1, 2018. According to the renewal application the school will grow to serve 780 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; and, 2) approved a five year renewal on December 11, 2017.
 - **Leadership Preparatory Canarsie Charter School**, located at 1001 E. 100th Street, Brooklyn, NY 11236 and 1070 E. 104th Street, Brooklyn, NY 11236, both in CSD 18, currently serving approximately 501 students in grades K-8, seeks a five year renewal of its authority to operate commencing August 1, 2018. According to the renewal application the school will grow to serve 780 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; and, 2) approved a five year renewal on December 11, 2017.

Please take further Notice that the SUNY Trustees have or will send the proposed renewal charter(s) to the New York State Board of Regents for approval or action consistent with the New York Charter Schools Act of 1998 (as amended).
