SUBJECT: Third Notice of Charter Application(s) – Operation of Law

DATE: July 10, 2018

This third and final Notice, pursuant to New York Education Law § 2857(1), is to inform you that the State University of New York Board of Trustees (the "SUNY Trustees"), in its capacity as a charter authorizer, approved application(s) for the charter school(s) listed below, sent the application(s) to the New York State Board of Regents, and the application(s) have been approved by operation of law in accordance with the New York Charter Schools Act of 1998 (as amended, the "Act"). As the Act requires no further action, this will be the last notice on these items. A description of the application(s) follows:

- **Brooklyn Dreams Charter School**, located at 259 Parkville Avenue, Brooklyn, NY 11230 in Community School District ("CSD") 22, serving approximately 678 students in grades K-8, sought a five year renewal of its charter commencing August 1, 2018. According to the renewal application, the school would grow to serve 712 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on February 13, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.
- **Brooklyn Excelsior Charter School**, located at 856 Quincy Street, Brooklyn, NY 11221 in CSD 16, serving approximately 742 students in grades K-8, sought a five year renewal of its charter commencing August 1, 2018. According to the renewal application, the school would serve 742 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on February 13, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.

- **Coney Island Preparatory Public Charter School**, located at 315 Avenue U, Brooklyn, NY 11223 in CSD 21, serving approximately 1,032 students in grades K-12, sought a five year renewal of its charter commencing July 1, 2018. According to the renewal application, the school will continue to serve approximately 1,032 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on February 13, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.
- **DREAM Charter School**, located at 1991 2nd Avenue, New York, NY 10029 in CSD 4, serving approximately 474 students in grades K-8, sought a five year renewal of its charter commencing July 1, 2018. According to the renewal application the school would grow to serve 922 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on December 12, 2017; and, 3) the renewal was approved by operation of law on June 4, 2018.
- **Family Life Academy Charter School**, an education corporation operating more than one school, sought to renew its authority to operate the following charter school:

 - **Family Life Academy Charter School**, located at 14 West 170th Street, Bronx, NY 10452 in CSD 9, serving approximately 312 students in grades K-5 sought a five year renewal of its authority commencing August 1, 2018. According to the renewal application the school would grow to serve 416 students in grades K-5. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on February 13, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.
- **Harlem Village Academy Charter School**, located at 35 West 124th Street, New York, NY 10027, 244 West 144th Street, 4th Floor, New York, NY 10030 and 74 West 124th Street, New York, NY 10027, all in CSD 5, serving approximately 958 students in grades K-12 sought a five year renewal of its charter commencing August 1, 2018. According to the renewal application, the school would serve 907 students in grades K-12. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on February 13, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.
- **New World Preparatory Charter School**, located at 26 Sharpe Avenue, Staten Island, NY 10302 in CSD 31, serving approximately 375 students in grades 6-8, sought a five year renewal of its charter commencing August 1, 2018. According to the renewal application, the school would grow to serve 685 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on January 9, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.

- **PAVE Academy Charter School**, located at 732 Henry Street, Brooklyn, NY 11231 in CSD 15, serving approximately 490 students in grades K-8, sought a five year renewal of its charter commencing July 1, 2018. According to the renewal application, the school would continue to serve approximately 490 students in grades K-8. The SUNY Trustees: 1) received the renewal application on or about August 15, 2017; 2) approved a five year renewal on February 13, 2018; and, 3) the renewal was approved by operation of law on June 11, 2018.
