This first Notice, pursuant to Education Law § 2857(1), is to inform you that the State University of New York Board of Trustees (the "SUNY Trustees"), in its capacity as a charter authorizer, has received the following application(s) to renew the charter(s) of or renew the authority to operate, the charter school(s) listed below. The SUNY Trustees, or their Charter Schools Committee, anticipate consideration of these applications as soon as October 4, 2018.

A description of the proposed actions follows:

- **Academy of the City Charter School**, located at 31-29 60th Street, Woodside, NY 11377, in Community School District ("CSD") 30, currently serving approximately 420 students in grades K-5, seeks a five year renewal of its charter commencing August 1, 2019. According to the renewal application, the school would grow to serve approximately 700 students in grades K-8.
- **Achievement First Brooklyn Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter schools:
 - **Achievement First Bushwick Charter School**, located at 125 Covert Street, Brooklyn, NY, 11207, and 1300 Greene Avenue, Brooklyn, NY 11237, both in CSD 32, currently serving approximately 824 students in grades K-8, seeks a five year renewal of its charter commencing August 1, 2019. According to the renewal application, the school would continue to serve 869 students in grades K-8.
 - **Achievement First East New York Charter School**, located at 557 Pennsylvania Avenue, Brooklyn, NY 11207, 158 Richmond Street, Brooklyn NY, 11208 and 35 Starr Street, Brooklyn, NY, 11221, all in CSD 19, currently serving approximately 1,190 students in grades K-12, seeks a five year renewal of its charter commencing July 1, 2019. According to the renewal application, the school would serve approximately 1,000 students in grades K-12.

 - **Boys Preparatory Charter School of New York**, located at 192 East 151st Street, Bronx, NY 10451, in CSD 8, currently serving approximately 450 students in grades K-5, seeks a five year renewal of its charter commencing August 1, 2019. According to the renewal application, the school would grow to serve approximately 900 students in grades K-8.
- **Explore Charter Schools of Brooklyn**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter schools:
 - **Explore Charter School**, located at 655 Parkside Avenue, Brooklyn, NY 11226, in CSD 17, currently serving approximately 540 students in grades K-8, seeks a five year renewal of its charter commencing August 1, 2019.  - **Explore Excel Charter School**, located at 1077 Remsen Avenue, Brooklyn, NY 11236 and 956 E. 82nd Street, Brooklyn, NY 11236, both in CSD 18, currently serving approximately 552 students in grades K-8, seeks a five year renewal of its charter commencing August 1, 2019. According to the renewal application, the school would serve approximately 564 students in grades K-8.
- **Icahn Charter School 4**, located at 1500 Pelham Parkway South, Bronx, NY 10461, in CSD 11, currently serving approximately 324 students in grades K-8, seeks a five year renewal of its charter commencing August 1, 2019. According to the renewal application, the school would continue to serve approximately 324 students in grades K-8.
- **Manhattan Charter Schools**, an education corporation operating more than one school, seeks to renew its authority to operate the following charter school:
 - **Manhattan Charter School**, located at 100 Attorney Street, New York, NY 10002 in CSD 1, currently serving approximately 290 students in grades K-5, seeks a five year renewal of its charter commencing July 1, 2019. According to the renewal application, the school would grow to serve approximately 1,078 students in grades K-12

According to the renewal application, the school would serve approximately 1,585 students in grades K-12.
