This Notice is to inform you that the State University of New York Board of Trustees (the "SUNY Trustees"), in its capacity as a charter authorizer, has received applications to revise the charter(s) of the charter school(s) listed below. Further, the SUNY Trustees, or their designees, the SUNY Charter Schools Committee or SUNY Charter Schools Institute (the "Institute"), anticipate consideration of this request as soon September 5, 2016.

A description of the proposed actions follows:

- **Uncommon New York City Charter Schools**, an education corporation with the authority to operate more than one school including **Kings Collegiate Charter School**, located at 1485 Pacific Street, Brooklyn, NY 11216 in Community School District ("CSD") 18 and 1084 Lenox Road, Brooklyn, NY 11212 in CSD 17, is scheduled to serve approximately 398 students in grades K and 5-8 in the 2016-17 school year. The education corporation requests to add a high school program beginning in the 2017-18 school year with approximately 150 students in the 9<sup>th</sup> grade and growing by one grade each year ending with a total of 1293 students in grades K-12 in the 2020-21 school year.
- **Brooklyn Prospect Charter School** is an education corporation with authority to operate two schools. **Brooklyn Prospect Charter School** located at 80 Willoughby Street, Brooklyn, NY 11201 in CSD 13 and 3002 Fort Hamilton Parkway, Brooklyn, NY 11218 in CSD 15 is scheduled to serve approximately 925 students in grades K-3 and 6-12, respectively, in the 2016-17 school year, and **Brooklyn Prospect Charter School – Downtown** is scheduled to open in 2016-17 school year with approximately 100 students in grade 6 at 80 Willoughby Street, Brooklyn, NY 11201 in CSD 13. The

education corporation requests that the elementary program currently part of Brooklyn Prospect Charter School be transferred to Brooklyn Prospect Charter School – Downtown allowing both programs to be located at one location and in one CSD. Therefore, for the 2016-17 school year Brooklyn Prospect Charter School would serve approximately 700 students in grade 6-12 at the Fort Hamilton Parkway location and Brooklyn Prospect Charter School – Downtown would serve approximately 325 students in grades K-3 and 6 at the Willoughby Street location.
