UPDATED PUBLIC NOTICE

SUBJECT: Second Notice of Charter Revision(s) and Extension(s) – SUNY Trustee Approval

DATE: March 29, 2019

This updated Notice, pursuant to New York Education Law § 2857(1), is to inform you that the State University of New York Board of Trustees (the “SUNY Trustees”), in its capacity as a charter authorizer, approved renewal(s) of the charter(s) of the charter school(s) listed below.

Extensions

- **Success Academy Charter Schools – NYC**, an education corporation with the authority to operate more than one school, requested an extension of the authority to operate the following schools. The SUNY Trustees: 1) received the extension request on or about December 21, 2018; and, 2) approved the extensions on February 11, 2019.
 - **Success Academy Charter School – Hudson Yards**, located at 500 West 41st Street, New York, New York 10036 in Community School District (“CSD”) 2, chartered to serve 250 students in grades K-2, sought an extension of its charter to commence October 7, 2019 and terminate July 31, 2022 to allow for five years of instruction.
 - **Success Academy Charter School – Bushwick**, located at 139 Menahan Street, Brooklyn New York 11221 in CSD 32, chartered to serve 380 students in grades K-3, sought an extension of its charter to commence October 7, 2019 and terminate July 31, 2021 to allow for five years of instruction.
 - **Success Academy Charter School – NYC 6**, proposed to locate in CSD 14, sought an extension of its charter to commence October 7, 2019 and terminate July 31, 2024 to allow for five years of instruction.
 - **Success Academy Charter School – NYC 12**, proposed to locate in CSD 24, sought an extension of its charter to commence October 7, 2019 and terminate July 31, 2024 to allow for five years of instruction.

- **Success Academy Charter School – NYC 14**, proposed to locate in CSD 30, sought an extension of its charter to commence October 7, 2019 and terminate July 31, 2024 to allow for five years of instruction.

Mergers

- **Democracy Prep New York Charter Schools**, an education corporation with the authority to operate more than one school, sought to merge with the following education corporation:
 - **Democracy Prep Endurance Charter School**, authorized by the New York State Board of Regents and located at 250 West 127th Street, New York, New York 10027 in CSD 5;

such that when the merger is approved, Democracy Prep New York Charter Schools would be the successor education corporation. The SUNY Trustees: 1) received the revision application on or about December 10, 2018; and, 2) approved it on March 4, 2019.

- **KIPP NYC Public Charter Schools II**, a charter school education corporation authorized by SUNY currently has authority to operate:
 - **KIPP Freedom Charter School II** to be located in CSDs 7, 10 or 11; and,
 - **KIPP Freedom Charter School III** to be located in CSDs 7, 10 or 11;

Sought to merge with the following education corporation:

- **KIPP NYC Public Charter Schools**, authorized by the New York State Board of Regents (“Board of Regents”) with the authority to operate:
 - **KIPP Always Mentally Prepared (“AMP”) Charter School** located at 1224 Park Place, Brooklyn, New York 11213 in CSD 17 and 201 East 144th Street, Bronx, New York 10451 in CSD 7.
 - **KIPP Infinity Charter School** located at 625 West 133rd Street, New York, New York 10027 in CSD 5.
 - **KIPP S.T.A.R. College Prep Charter School** located at 625 West 133rd Street, New York, New York 10027 and 433 West 123rd Street, New York, New York 10027 in CSD 5.
 - **KIPP Washington Heights Academy Charter School** located at 586 West 177th Street, New York, New York 10033 and 21 Jumel Place, New York, New York 10032 in CSD 6.
 - **KIPP Freedom Charter School** located at 2246 Jerome Avenue, Bronx, New York 10453 and 1825 Prospect Avenue, Bronx, New York 10457 in CSD 10;

such that when the merger is approved, KIPP NYC Public Charter Schools II would be the successor education corporation under the name “**KIPP NYC Public Charter Schools.**” (Please note **KIPP NYC Public Charter Schools** operates **KIPP NYC College Prep High School** located at 201 East 144th Street, Bronx, New York 10451 in CSD 7.) The SUNY Trustees: 1) received the revision application on or about January 23, 2019; and, 2) approved it on March 4, 2019.

Revisions

- **Academy of the City Charter School**, located at 31-29 60th Street, Woodside, New York 11377 in CSD 30, currently chartered to serve 420 students in grades K-5, sought to add an at-risk preference to its admissions policy for the 2019-20 school year and beyond providing a preference for students who reside in housing operated by the New York City Housing Authority within CSD 30. The SUNY Trustees: 1) received the revision request on or about December 10, 2018; and, 2) approved the request on February 11, 2019.
- **Achievement First Brooklyn Charter Schools**, an education corporation with the authority to operate more than one school, requested an enrollment revision for the following school:
 - **Achievement First Voyager Charter School**, located at 601 Parkside Avenue, Brooklyn, New York 11226 and 532 Albany Avenue, Brooklyn NY 11203, both in CSD 17, currently chartered to serve 366 students in grades K and 5-7, sought an enrollment revision to serve 260 students in grades K and 5-7 for the 2018-19 school year growing to serve 560 students in grades K-2 and 5-9 by the 2020-21 school year, the final year of the current charter term. The SUNY Trustees: 1) received the revision request on or about December 21, 2018; and, 2) approved the request on February 11, 2019.
- **DREAM Charter School**, an education corporation with the authority to operate more than one school, sought to add an at-risk preference to its admissions policy for the 2019-20 school year and beyond for all schools it is authorized to operate providing a preference for students displaced by natural disasters. The SUNY Trustees: 1) received the revision request on or about December 10, 2018; and, 2) approved the request on February 11, 2019.
- **Our World Neighborhood Charter School 2**, located at 135-25 79th Street, Howard Beach, New York 11414 in CSD 27, currently chartered to serve 153 students in grades K-1, sought an enrollment revision to serve 156 students in grades K-2 for the 2018-19 school year growing to serve 453 students in grades K-5 by 2022-23, the final year of the current charter term. The SUNY Trustees: 1) received the revision request on or about December 10, 2018; and, 2) approved the request on February 11, 2019.

- **Success Academy Charter Schools - NYC**, an education corporation with the authority to operate more than one school, has requested the following revisions to align enrollments with current school opening and growth timelines as well as available facility space. The SUNY Trustees: 1) received the revision requests on or about November 2, 2018; and, 2) approved the requests on February 11, 2019.
 - **Success Academy Charter School – Bed Stuy 3**, located at 70 Tompkins Avenue, Brooklyn, New York 11206 in CSD 14, currently chartered to serve 380 students in grades K-3, requests an enrollment revision to serve zero students for the 2018-19 school year, 151 students in grades 5-6 in the 2019-20 school year, and 295 students in grades 5-7 in the 2020-21 school year, the final year of the current charter term.
 - **Success Academy Charter School – Bensonhurst**, located at 99 Avenue P, Brooklyn, New York 11204 in CSD 21, currently chartered to serve 675 students in grades K-5, requests an enrollment revision to serve 602 students in grades K-4 for the 2018-19 school year, and 566 students in grades K-4 and 9-10 in the 2023-24 school year, the final year of the current charter term.
 - **Success Academy Charter School – Bronx 1**, located at 339 Morris Avenue, Bronx, New York 10451 in CSD 7, currently chartered to serve 863 students in grades K-9, requests an enrollment reduction to serve 739 students in grades K-6 for the 2018-19 school year, and 446 students in grades K-4 in the 2024-25 school year, the final year of the current charter term.
 - **Success Academy Charter School – Bronx 2**, located at 450 St. Pauls Place, Bronx, New York 10456 and 270 East 167 Street Bronx, New York 10456, both in CSD 9, currently chartered to serve 870 students in grades K-9, requests an enrollment revision to serve 886 students in grades K-8 for the 2018-19 school year, and 446 students in grades K-4 in the 2024-25 school year, the final year of the current charter term.
 - **Success Academy Charter School – Bronx 4**, located at 885 Bolton Avenue, Bronx, New York 10473 in CSD 8, currently chartered to serve 675 students in grades K-5 requests an enrollment revision to 602 students in grades K-4 for the 2018-19 school year, and 583 students in grades K-4 and 9-10 in the 2023-24 school year, the final year of the current charter term.
 - **Success Academy Charter School – Cobble Hill**, located at 284 Baltic Street, Brooklyn, New York 11201 in CSD 15, currently chartered to serve 880 students in grades K-7, requests an enrollment revision to serve 416 students in grades K-4 for the 2018-19 school year, and 536 students in grades K-4 and 9-10 in 2021-22, the final year of the current charter term.

- **Success Academy Charter School – Harlem 4**, located at 240 West 113th Street, New York, New York 10026 in CSD 3 and 461 West 131st Street, New York, New York 10027 in CSD 5, currently chartered to serve 621 students in grades K-8, requests an enrollment reduction to serve 417 students in grades K-4 for the 2018-19 school year and the same enrollment through the 2022-23 school year, the final year of the current charter term.
- **Success Academy Charter School – Harlem 5**, located at 301 West 140th Street, New York, New York 10030 and 175 West 134th Street, New York, New York 10030, both in CSD 5, currently chartered to serve 816 students in grades K-9, requests enrollment reduction to 758 students in grades K-8 for the 2018-19 school year, and 708 students in grades K-8 in the 2024-25 school year, the final year of the current charter term.
- **Success Academy Charter School – Harlem 6**, located at 461 West 131st Street, New York, New York 10027 in CSD 5, currently chartered to serve 250 students in grades K-2, and 675 students in grades K-5 in the 2021-22 school year, the final year of the current charter term, requests an enrollment revision to serve 1,917 students in grades K-8 in the 2021-22 school year.
- **Success Academy Charter School – Rosedale**, located at 147-65 249th Street, Queens, New York 11422 and 132-55 Ridgedale Street, Queens, New York 11413, both in CSD 29, currently chartered to serve 675 students in grades K-5, requests enrollment revision to serve 602 students in grades K-4 for the 2018-19 school year, and 575 students in grades K-4 and 9-10 in the 2023-24 school year, the final year of the current charter term.
- **Success Academy Charter School – Washington Heights**, located at 701 Fort Washington Avenue, New York, New York 10040 in CSD 6, currently chartered to serve 675 students in grades K-5, requests an enrollment revision to 602 students in grades K-4 for the 2018-19 school year, and 579 students in grades K-4 and 9-10 in the 2023-24 school year, the final year of the current charter term.

Please take further Notice that the SUNY Trustees will send the proposed extension(s) and revision(s) to the New York State Board of Regents for approval or action consistent with the New York Charter Schools Act of 1998 (as amended).
